

Our Rates Explained



Octane offers a **variable rate** which is linked to the Bank of England Base Rate (BBR).

Octane charge a Margin + the BBR. **The Margin is fixed and only the BBR is variable.**

How our rates work

For example, where the Margin is 0.33% per month (3.96% per year) + BBR:

Rate calculation	
Margin:	3.96% per year
BBR:	+ 5.25% per year (currently)
Total:	= 9.21% per year/ 0.77% per month

If the BBR was to decrease to 5.00% during the loan term, the rate would be affected as follows:

Rate calculation	
Margin:	3.96% per year
BBR:	+ 5.00% per year (decreased)
Total:	= 8.96% per year/ 0.75% per month

The monthly rate could go up or down during the term, depending on BBR movements.

The new rate would only be applied from the day the BBR changes.
